- 1. Update on the Seattle Neighborhood Greenways / SDOT / Seattle School Traffic Safety Committee work on creating safer routes to schools for the new Eagle Staff (former Wilson Pacific) Campus:
 - a. First round of on-site audits done
 - b. In early-mid Jan. we will run a public on-line survey about safe routes to schools (gather current opinion of existing conditions and needed improvements)
 - c. In late January the School Traffic Safety Committee will tour the area immediately near the school (we will be preparing an interim report to them prior to then)
 - d. In late Jan Feb we will have a community meeting for people to digest the findings of the survey and gather more info on existing conditions and needed improvements
 - e. We will follow that up with additional on-site walks to audit identified areas (public invited)
 - f. We will be preparing our final report and recommendations in March and April
- 2. UW Landscape Architecture / Urban Planning Project in the area Masters Students in their "capstone class" will be working during the next 6 months on a variety of projects in Licton Springs, Haller Lake, and North Aurora areas.
