Spencer Williams, Legislative Assistant to Councilmember Rob Johnson

- Review of November 29, 2016 ALUV community charrette (held at North Seattle College) and materials
 - Spencer Williams provided handouts summarizing the November 29, 2016, Aurora Licton Urban Village charrette including proposed zoning maps and comments from attendees
 - HALA Rezone Draft Environmental Impact Statement (DEIS) Currently scheduled to be released in May 2017 with a 45 day comment period
 - Consider It a new city tool for citizens to engage with and comment on proposals
- Discussion/Suggestions/Questions:
 - ALUV wants to see neighborhood design guidelines
 - ALUV mentioned that the City should consider waiving or reducing MHA linkage fees in the Aurora Licton Springs Urban Village to incentivize development within the urban village
 - ALUV mentioned how the urban village is losing prime commercial properties (proposed mini-storage units) because of auto-oriented zoning along Aurora Avenue
 - ALUV mentioned that it would like to see the City impose a moratorium on new auto-oriented uses while HALA zoning proposals are reviewed
 - If MHA doesn't pass, ALUV stated that the City should implement the ALUV commercial rezones along the corridor regardless
 - Spencer mentioned MHA is City law; the framework is in place and that zoning changes implement it
 - ALUV recognizes the value of the rezoning of the Aurora Corridor for our urban village and is willing to see the ALUV rezones to go first or early if possible
 - HALA Rezone Timeline
 - Final EIS Fall 2017

- Council Action Early 2018
- ALUV Comment: The Seattle Municipal Code description of the C1, C2 zones emphasize its auto-orientation by stating the zoning is appropriate for properties abutting a state highway. That line should be removed.
- Spencer said ideas can be sent to him
 - He said ideally he would like to see a letter from ALUV by the end of June in case time is needed for him to study ideas that are raised
- Spencer mentioned he believes the North Seattle Chamber of Commerce and Aurora Merchants Association were invited to November 29, 2016 community charrette
